

SUBJECT: Amendment to CY2022 Recharge for Resiliency (R4R) guide

1. This memorandum will serve as an amendment to the CY2022 R4R guide. Individual commanders may now choose to designate Airmen/Guardians' spouses/dependents assigned to the requesting unit as authorized participants of the Unite program for the remainder of the 2022 calendar year. The changes in authorized Unite program participants will be reflected in the CY2023 and CY2024 R4R program guides.
2. The addition of spouses/dependents as authorized Unite program participants will not result in additional funding for the units. Funding will continue to be determined by the number of individuals assigned to the squadron or unit according to the current Unit Manning Document (UMD).
